Minutes of the Sixteenth Academic Council Meeting (Virtual Mode)

Venue: Conference Hall of the College

Date: 28-11-2020.

At the outset, Dr.Udaya Kumar Susarla, Principal extended a warm welcome to all the members of the Academic Council.

Agenda Item 1: Approval of the minutes of the fifteenth academic council meeting held on 04th November, 2020

Approval: Minutes of the Previous Academic Council meeting already circulated were approved without any changes

Agenda Item 2: Approval of Academic regulations AR20 of B.Tech, M.Tech and MBA Programmes

Discussion:

- Principal apprised the members that in framing B. Tech - AR20 Regulations the college has generally followed the autonomous regulations of the JNTUH. He also briefed the members on the various Activity oriented (Non-Laboratory) courses introduced in all B.Tech Programmes and Academic Requirements to be fulfilled for completing these Activity oriented(Non-Laboratory) courses.
- Principal then presented M.Tech and MBA Academic Regulations (AR20) and briefed the members that generally regulations of JNTUH autonomous were followed. One minor change is provision for Make up Test for absentees in Mid Examinations of Theory and Laboratory based on the experience with previous batches where students could not easily clear the courses due to low mid examination marks on account of absence in one or both mid examinations. Dr K. Ramamohan Reddy, Director Academic Audit Cell suggested that the makeup test should be made applicable only in genuine cases such as hospitalization or serious illness supported with necessary medical certificate from the hospital and should be approved by the College Academic Committee.

Approval: Academic regulations AR20 of B. Tech, M. Tech and MBA Programmes were approved with changes incorporated as per the above suggestion.

Agenda Item 3: Approval of Program structure and syllabus of First year and Second year of all the B. Tech (UG) programs under AR 20 regulations.

Discussion:

- Principal informed the members that four new courses, viz., CSE (AI&ML), CSE (Cyber Security), CSE (Data Science), CSE (Internet of Things) were introduced under the department of CSE. He then invited all Heads of the Departments to present the program structure of their departments.
- Heads of the Departments presenting the program structure of theory and lab courses that fall under the purview of their department informed the council that these program structures have already been discussed and approved by respective BoS having representation of JNTUH nominees also.

Approval: After the deliberations on the proposed Program structure and syllabus, the academic council approved the program structure and syllabus of First year and Second year of all the B. Tech (UG) programs under AR 20 regulations as follows:-

Agenda Item 4: Approval of Program structure and syllabus of the M.Tech (CSE) and MBA programs under AR 20 Regulations.

Discussion:

- HoD-CSE indicated that the following changes are made from AR18 program structure in line with JNTUH autonomous program structure. The revised program structure has been approved by the BoS concerned having representation of JNTUH nominee also.
 - i. Number of courses in the category of Program specific electives has been increased from three to four
 - ii. The nomenclature “Project Work” is changed to “Dissertation work”
- HoD-MBA indicated that the following change is made from AR18 program structure. The revised program structure has been approved by the BoS concerned having representation of JNTUH nominee also:
 - “Comprehensive Viva-Voce” is removed as per JNTUH program structure for MBA. In its place a course in “Functional English” has been included increasing the total credits from 104 to 105.

Approval: The Academic Council deliberated on the AR20 program structures for M.Tech and MBA and approved the same.

Agenda Item 5: Ratification of Revaluation results of B. Tech IV year-II semester regular examinations under AR16 regulations, MBA II year-II semester regular examinations under AR18 regulations, MBA II year-II semester supplementary examinations under AR16 regulations.

Discussion: CoE presented the results of revaluation of examinations mentioned under agenda item 5. He further mentioned that these results have been vetted by Examination results committee nominee of JNTUH.

- Dr. Ch. Venkata Ramana Reddy, Professor of Chemistry, JNTUH suggested to have a credit free certification courses in mandatory courses on “Artificial Intelligence and Cyber Security” and the test may be administered by faculty of CSE.

Principal thanked the members for their valuable suggestions and inputs and assured them that their suggestions would be examined for implementation.
